The Board will discuss, consider and possibly take action on the following matters:

13. Review and approve District Emergency Response Plan, as necessary;

 - b. review and approve pay applications and change orders, as necessary;
15. Fire Chief's Report:
 - a. summary of District and NFR Financials and Call Activity;
 - b. review fleet matters;
 - c. review Department standard operating policies and standard operating guidelines;
 - d. review service developments in and around the District's service area; and
 - e. status of Fire Dispatch Services Agreement between Montgomery County Fire Chief's Association and The Woodlands Township;

17. Review District real estate matters;
18. Review City of Conroe annexation matters;
19. Review and adopt any necessary revisions to the District's Policies and Procedures Manual including Purchasing Policy, if necessary;


20. Executive Session pursuant to Chapter 551, Texas Government Code, (Open Meetings Act) to discuss District matters, as may be necessary;
21. Miscellaneous inquiry pursuant to Section 551.042, Texas Government Code, (Open Meetings Act) to hold limited discussions; and
22. Adjourn.

The Board of Commissioners is authorized by the Open Meetings Act to convene in closed or Executive Session for certain purposes. These purposes include: receive legal advice from its attorney(s) pursuant to §551.071, Texas Government Code; discussing real property matters pursuant to §551.072, Texas Government Code; discussing gifts and donations pursuant to §551.073, Texas Government Code; discussing personnel matters pursuant to §551.074, Texas Government Code; and, discussing security personnel or devices pursuant to §551.076, Texas Government Code. If the Board decides to enter into Executive Session regarding any item on this agenda, the Presiding Officer will announce that an Executive Session will be held and will identify the time to be discussed and provision of the Open Meetings Act that authorizes the closed or Executive Session.

The Board of Commissioners, NFR Board of Directors and/or District staff may inquire about a subject not specifically listed on this agenda pursuant to §551.042, Texas Government Code. Responses are limited to a recitation of existing policy or a statement of specific factual information given in response to the inquiry. Any deliberation or decision shall be limited to a proposal to place the subject on the agenda of a future meeting.
